Erratum

The following errors in the *RCMP Emergency Response Team (ERT)* Foundational Document have come to the attention of Commission Counsel:

1. Paragraph 45 – ATAK

In paragraph 45, as well as in the Special Terms section, ATAK is defined as “Android Team Awareness Kit”. It should instead be “Android Tactical Assault Kit”.

2. Paragraph 98 – Five Houses

In paragraph 98, “Five Houses” is erroneously spelled “Five House”.

3. Special Terms – Clear

In the Special Terms section, clear is defined as “the tactical walkthrough of an area or building”. A more accurate definition is “a methodical and tactical approach for entering a room, building, or other area while checking for and neutralizing any threats to the safety of those entering that space”.
