Erratum

The following error in the *Plains Road, Debert* Foundational Document has come to the attention of Commission Counsel:

1. Paragraph 130 – Time of Arrival of EMRT

Paragraph 130 of the *Plains Road, Debert* Foundational Document states: "According to Cpl. Ivany, he and fellow EMRT member Cst. Jeff Mahar arrived at Heather O'Brien's Jetta and took control of the scene from Csts. Coleman and Fahie. He thought it likely that they had arrived on scene by 10:14:41 a.m." The GPS data for Csts. Coleman and Fahie's car indicates that they arrived at the scene at 10:15:23. Given the evidence that Csts. Fahie and Coleman were the first on the scene, it is most likely that the EMRT team arrived sometime after 10:15:23, rather than 10:14:41, as is suggested in the Foundational Document.
