Erratum

The following error in the *Shubenacadie* Foundational Document has come to the attention of Commission Counsel:

1. Figure 11 – Highway 212

In Figure 11, the road highlighted in yellow is labelled as “Hwy. 212” and the checkpoint is labelled as “Hwy. 212 & Grove Rd”. While this road is Highway 212, the Foundational Document refers to the road by its street name “Old Guysborough Road”, as opposed to its highway number, throughout. The map’s labels should read “Old Guysborough Road” and “Old Guysborough Rd & Grove Rd”.
